7. Approval of Minutes (January 2023)

B. Vietnam Veteran Lapel Pin Presentation Ceremony (April 22, 2023).

Committee Member Warren Williams give the committee update information about the Vietnam Veteran Lapel Pin Ceremony and the sign-up process . This year 2023 is the 50th Anniversary of the Vietnam War. The VFW and The Veterans Committee are planning to have the Vietnam Veteran Lapel Pin Presentation for the Vietnam War Veterans of Bergenfield will be on April 22nd, 2023. This Commemoration Lapel Pin is for all United States veterans who served on active duty in the Armed Forces at any time during the Vietnam War Era (November 1, 1955 to May 15, 1975), regardless of location of service. Committee Member Warren Williams is request that Councilman Rafael Marte, to get the Borough Administrator to place the Vietnam Veteran Lapel Pin information out to the veterans of Bergenfield to register for this lapel pin. The date of the actual presentation ceremony is planned for April 22nd. There will be more updated information by the next committee meeting.

A. Pre-Planning for Events for 2023.

1. Grand Marshal Nomination for 2023 (Update): The committee has approved the nomination selection for Grand Marshal for the 2023 Memorial Day Ceremony and Parade is Mr. Peter Mathews. Peter Mathews is a Bergenfield resident and Vietnam War Veteran; He served in the U.S. Army as a sergeant with 1st Cavalry. The committee approved Peter Mathews for this year Grand Marshal, to due this long-time effort working to relocate the family members of North Vietnamese soldier' diary that Peter Mathews, recovered from the battle of Dak To (Hamburger Hill) in November 1967. Peter Mathews has finally located the family members of North Vietnamese soldier who was KIA in the battle of Dak To, were Mr. Mathews is schedule to return the country of Vietnam to meet with dead soldier's family and to return the diary after a long-time search of 50 years. Peter Mathews is a member of the Bergenfield VFW Post which the members of Veterans Committee and VFW Post great appreciate Peter Mathews great efforts and service in preserving some history of the Vietnam War.

Committee Member Edgar Garcia attended the PACT Act Enrollment Event- Lyons VA Center.

This PACT ACT Enrollment Event was for veterans who may have experienced various forms of toxic exposures during their military service. This event will assist any veteran who needs assistance to enroll into the VA health system and provide screening and health care and resources. The PACT ACT is for all veterans who may have possible exposures to some of following; Opening Burn Pits/Airborne Hazards, Gulf War Related Exposures, Agent Orange, Radiation, Camp Lejeune Contaminated Water Exposure and other exposures that may occur during military service. Its very important that veterans who haven't register or enrolled into the VA Health System to do so now.


